Two big traps and a dozen solutions for anyone who deals with intellectual property.

Bankruptcy Judge Neil W. Bason and attorney Malhar S. Pagay will discuss the dangerous intersection of intellectual property law and bankruptcy law. From the moment you draft an agreement or sue to enforce it, to the time when one of the parties is contemplating or in bankruptcy, intellectual property can be either your pot of gold or your lead weight. After explaining two big traps for the unwary (no knowledge of bankruptcy law required), the discussion will explore a dozen solutions to get beyond *In re Catapult Entertainment, Inc*, and the lesser-known *In re Hernandez*.
